

**C. AGENTE DEL MINISTERIO PUBLICO DE PLAYA DEL CARMEN
P R E S E N T E**

The undersigned [REDACTED] mexican, legal age, promoting as plaintiff, addressed at [REDACTED] C.P. 77 [REDACTED] Playa del Carmen, Solidaridad, Quintana Roo, respectfully appear and present the following:

That I come to file formal complaint against Mr. SEAN O'NEAL and/or whoever is responsible, with possible address at 6719 Abbottswood Drive, Rancho Palos Verdes, California 90275, USA, for the commission of the facts narrated hereunder so that if the Public Ministry considers these facts as crimes the criminal action is brought in accordance with law:

FACTS

1. Since May 11th, 2013, I started to work as a cashier at the grocery store called Super City located at Plaza Progreso, from 06:00 to 15:00 hours, even though I worked at the evenings shift sometimes, from 15:00 to 22:00 hours, with my mother's authorization, who also worked there as chief cashier, because I was 17 years old.
2. Since I started working at the store mentioned above, Mr. Sean O'Neal was a frequent client, who arrived every morning to buy coffee. Mr. Sean O'Neal arrived to the store every morning, greeting all the employees, including me, and presented himself as a good person.
3. After two months I was working there and Mr. Sean O'Neal buying coffee, he started talking to me, asked me personal questions and said I was very pretty. I thought he was a good person. Everyday we started talking each other and he even said he would like to take me out some day on a date.
4. Sometime, Mr. Sean O'Neal told my mother that I was a very good daughter and that he only had good intentions towards me.
5. On June 6th, 2013, at 15:00 hours, Mr. Sean O'Neal approached me outside the store I worked at after my working shift, and invited me to lunch. After saying no a few times, he convinced me saying that he only wanted to get to know me and have a good conversation with me, so I agreed. During lunch, he was very kind with me and told me that he fell in love with me since the first moment he saw me.
6. After lunch, he offered me a ride home in his car and I accepted. He asked me where did I live and I explained him how to get to my house. I also told him that I lived with my mother. However, he suddenly change course and got inside a hotel on Av. Colosio, called Rumayor. When I realized where we were, I started to demand him to take me home immediately but he ignored me. I tried to get out of the car but he grabbed my arm firmly and told me that if I say anything he would hurt me and that he knew where I lived. Its worth mentioning that Mr. Sean O'Neal is a very tall, big and strong person, and about fifty years old.
7. Then he took me down from the car violently, carried me to the room and threw me on the bed where he forced me to have sexual intercourse and copulate with him. He threatened me with hurting my parents if I told anyone what happened, and that from now on I was going to be his slave and girlfriend.
8. We got out from the above mentioned hotel afterwards and he took me to a pharmacy where he gave me money and told me to buy me an "emergency pill". I was very scared that he could hurt me again, so I obeyed him and took the pill.
9. The above mentioned, repeated approximately once a week for a period of five months. Every time Mr. Sean O'Neal showed up by surprise at the end of my shift and he forced me to get in his car under the threat that if I didn't obey him, he would hurt my family, he took me to the same hotel where he forced me to have sexual intercourse and copulate with him, and then take me to buy an "emergency pill".
10. During this time, Mr. Sean O'Neal continued going to the Super City where me and my mother worked to buy coffee and act normally, treating me like if I was his girlfriend. He even told my mother that he wanted to marry me as soon as I turned 18 years old.

11. In early October, 2013, I realized that I was pregnant because one day I started to bleed and had cramps because I lost the baby. The next few days I reported sick at work. A few days later, Mr. Sean O'Neal approached me as usual and I told him that I was hurt because I just lost a baby. However, he didn't care and took me to the hotel and forced me to have sexual intercourse with him.
12. A month before I turned 18 years old, Mr. Sean O'Neal told me that he was going to the USA to visit his mother that was sick and as soon as he got back, he was going to marry me and treat me better.
13. Since that day, I haven't seen him again. However, I live with fear that he comes back one day and try to hurt my family.

3. Agree time and form to present the testimony offered herein.
4. Prior formalities, execute criminal action with petition of an arrest warrant.
